## Specifications & Warranties

### Specifications on Seating

Standard Frame construction includes:

\* Kiln-dried hardwood frames ONLY from SFI (Sustainable Forestry Initiative) Certified replenished forests, with glued joints, double-doweled, corner blocked and screwed (where needed). Lag bolted on exposed wood four-legged seating.

Seating:

\* Sinuous loop steel spring linked together with 16-gauge fiber wire, fastened with Vertex clips to establish a firm platform seating. 1.5 oz. Westpad fiber covered on Sinuous. Coil spring seating included on loose seat cushions.

Foam:

\* ALL foam features our exclusive Lone Meadow Integrity + Foam System (tm). Lone Meadow foam is 100% recycled, rebond material. 3.5 lb., HR density with dacron wrap. For loose seat chairs, sofas, and loveseats, Lone Meadow Foam includes coil spring inserts for luxurious, residential comfort and contract durability. All foam materials comply with CA 117 AND CMHR flammability requirements. Special requests are available for CA 133 specifications.

Finish:

\* Lone Meadow offers our high quality, water base, polished lacquer finishes with the lowest VOC (volatile organic compound) emissions possible for contract use.

Sleeper Sofa Mechanism:

\* Includes Contract quality mechanism with three-year warranty. Specific contract mechanisms available upon request (mattress specs attached).

### Warranty and Service

Fully Upholstered Seating:

\* A five-year warranty applies to the frame and spring construction only. Lone Meadow LLC warrants these to the original purchaser to be free from manufacturing defects under normal use. Foam and sleeper sofa mattresses are not warranted by the company.

Exposed Wood Seating:

\* A one-year warranty applies to the frame construction, five years for spring construction when applicable. Lone Meadow warrants these to the original purchaser to be free from manufacturing defects under normal use. Foam is not warranted by the company.

Textiles:

\* Textiles are not warranted by Lone Meadow under any circumstances, including but not limited to problems arising from low tensile strength, pilling, seam slippage, insufficient backing, fading, dye lot failure, wearing or any damage resulting from any cleaning process, substance or operation.

Service:

\* To obtain service under these warranties, problems must be reported to the purchasing company or agent. A copy of the original invoice must be presented by the original purchaser. The purchasing company or agent is to contact JL Furnishings, LLC for service arrangements, not the end user.
